ROUTES OF EXPOSURE:

INHALATION of vapor or spray mist.

EYE or SKIN contact with the product, vapor or spray mist.

4. First Aid Measures

EYES: Flush eyes with large amounts of water for 15 minutes. Get medical attention.

UNUSUAL FIRE AND EXPLOSION HAZARDS:

Closed containers may explode (due to the build-up of pressure) when exposed to extreme heat.

6. Accidental Release Measures

8. Exposure Controls and Personal Protection

PRECAUTIONS TO BE TAKEN IN USE:

Use only with adequate ventilation.

Avoid contact with skin and eyes. Avoid breathing vapor and spray mist.

Wash hands after using.

This coating may contain materials classified as nuisance particulates (listed "as Dust" in Section 2) which may be present at hazardous levels only during sanding or abrading of the dried film. If no specific dusts are listed in Section 2, the applicable limits for nuisance dusts are ACGIH TLV 10 mg/m³ (total dust), 3 mg/m³ (respirable fraction), OSHA PEL 15 mg/m³ (total dust), 5 mg/m³ (respirable fraction).

Removal of old paint by sanding, scraping or other means may generate dust or fumes that contain lead. assigned a Group 2B rating. In addition, the IARC summary concludes, "No significant exposure to titanium dioxide is thought to occur during the use of products in which titanium is bound to other materials, such as paint."
